3. The vendor or vendor employees must behave well with the customers, if any dispute arises then it will be subject to Ernakulam Jurisdiction. The **DRVKRO ONLINE PRIVATE LIMITED** will not be responsible or liable to pay any expenses incurred by the vendor for the resolving of the issue.
4. The vendors can also sell the **DRVKRO ONLINE PRIVATE LIMITED** packages, for which the vendors will receive the commission on per package sales.
